Truist Bank provides a wide range of banking and trust services for clients through 2,123 offices as of December 31, 2022 and its digital platform.

In 2022, Truist reconstructed our 2019 through 2022 greenhouse gas calculations from primary sources. By reconstructing our GHG emissions database, we ensured that all properties were included once and had complete and consistent information. In addition, by recalculating all years at once, Truist was able to incorporate the most recently published emissions factors and global warming potentials. Accordingly, our 2019 baseline and all other years have been restated.
