This Form of Proxy is solicited by and on behalf of the Board of Directors of Waste Connections, Inc. (the "Company").

- 1. Every holder of common shares of the Company ("Common Shares") has the right to appoint some other person or company of his or her choice, who need not be a shareholder, to attend and act on his or her behalf at the Meeting or any adjournment or postponement thereof. If you wish to appoint a person or company other than the persons whose names are printed herein, please insert the name of your chosen proxyholder in the space provided (see reverse).**
2. If your Common Shares are registered in the name of more than one holder (for example, joint ownership, trustees, executors, etc.), then all those registered should sign this proxy.
