
- Strong top line growth with revenues of \$201.9M, up 57% YoY driven by execution on our backlog
- Solid profitability with adjusted EBITDA (excluding non-recurring items) (1,2) of \$48.9M, up 77% YoY
- Robust adjusted EBITDA margin (1) of 24.2%
- Strong operating cash flow of \$46M, up 212% YoY
- Healthy backlog of \$1.2B at quarter end reflecting strong contract awards in 2022
- Flexible balance sheet with Net Debt to LTM adjusted EBITDA ratio of 1.2x at quarter end
- Reaffirmed 2023 full-year financial outlook





- Revenues of \$201.9M up 57% YoY driven by higher revenues across our three business areas with strong contributions from Satellite Systems and Robotics & Space Operations businesses
- Adjusted EBITDA (1) of \$48.9M up 10% YoY driven by higher work volume across our business areas; adjusted EBITDA excluding non-recurring items (1,2) up 77% YoY
 - Adjusted EBITDA margin (1,2) of 24.2% in Q1 2023 compares to 21.6% in Q1 2022 (excluding impact of historical ITC claims recognized in prior quarter) driven by disciplined SG&A cost control









- Backlog of \$1.2B at a healthy level following strong contract awards in 2022

Cash Generation & Financial Position








- Operating cash flow of \$46M in Q1 2023 reflects higher net income and positive contributions from working capital

Net Debt to LTM Adj. EBITDA (1)




