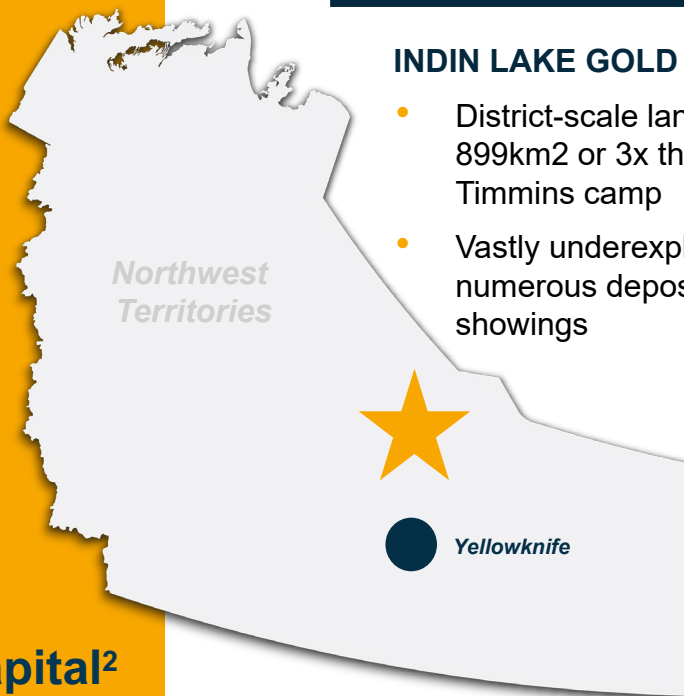

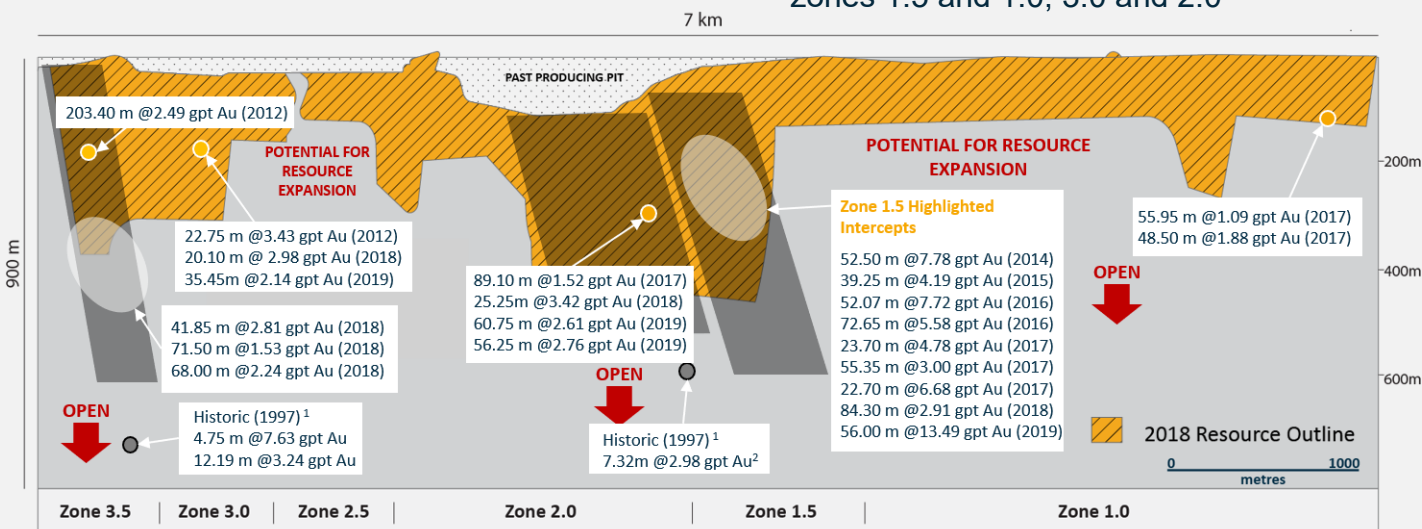

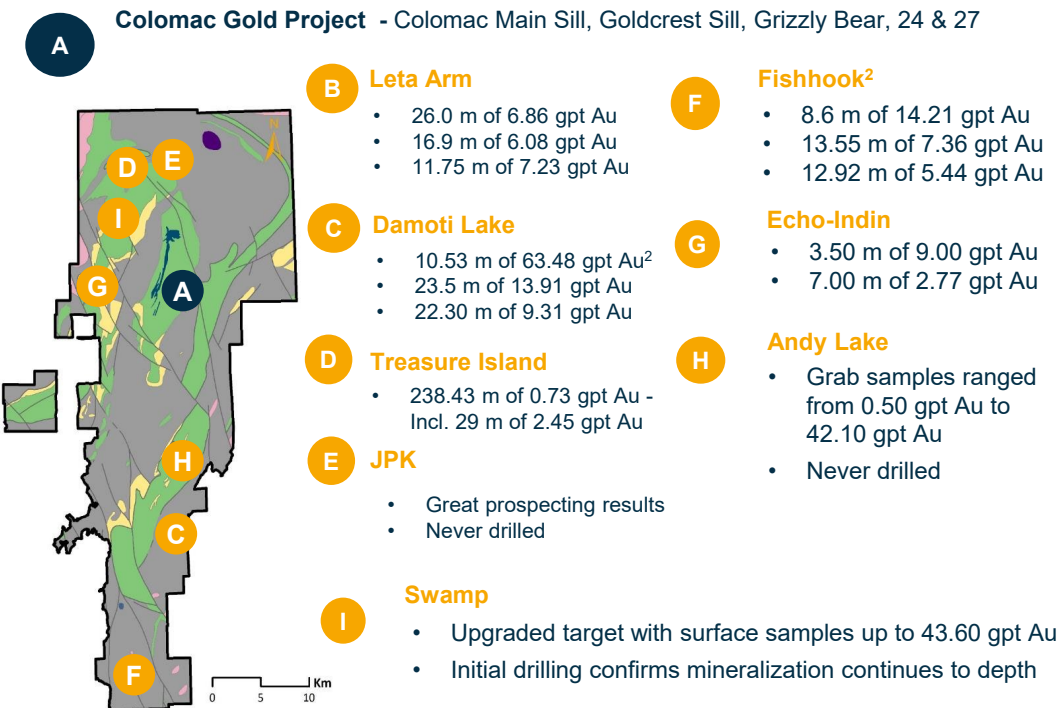
COLOMAC GOLD PROJECT - Colomac Main Sill
